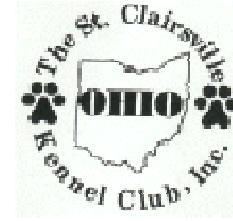

**DIRECTIONS**

**From Steubenville:** 22 west past the 250/Tappan Lake exit. Go another 1/4th mi. turn left at Highway Dept. sign. This is Industrial Park Rd. Follow to Gold Star Kennel on left.

**From Cambridge:** 22 east until the two lane road goes to four lanes. Turn right immediately, you are on Industrial Park Rd. Gold Star Kennel is past the Highway Dept. on left.

**Traveling on I70 East or West:** Take exit 216. Turn North on Rt. 9 near BP/Starfire gas station. Continue approx. 12 miles on Rt. 9. toward Cadiz. Make a left at the Industrial Park. There will be a sign for Cardinal Co. Follow til you see Gold Star Kennel on right.

**From Dover:** Take 77 South to 250 East. Then 22 West to the Highway Dept. sign. Turn left and follow Industrial Park Rd. to Gold Star Kennel on the left.

**CONFORMATION** Divided by Age and Sex  
 Puppy 3 - 6 months, 6 - 9 months, 9 - 12 months  
 Adult 12 months and up  
 Jr. Handling 8 - 12 years old  
 Sr. Handling 13 - 16 years old  
 Adult 17 years and up

Dogs with major points may be shown for exhibition only. Professional handlers may not enter Handling Classes, but may enter dogs owned by themselves in regular classes. All dogs in show trim - NO TAPES OR WEIGHTS.

**OBEDIENCE** Subnovice and Novice

**Class Eligibility** - Subnovice entrants - no legs toward CD or may enter for practice only. Novice - if you have a CD title, you must enter for practice only.  
**Awards** - Ribbons awarded, rosettes awarded for Best Adult, Best Puppy, Groups. Qualifying ribbons and Highest Scoring dog in match will be awarded for regular classes only.
